## Doncaster Stories Roald Dahl giveaway 2020

### National Literacy Trust

#### Rules for entry

These terms and conditions apply to the Doncaster Stories *Roald Dahl at home trail* and the associated giveaway. The promoters are the National Literacy Trust and Doncaster Stories.

1. The giveaway is open to children from Doncaster aged 7-11 (Years 3 - 6) and is free of charge to enter. Entries must be submitted by the child's parent or legal guardian together with their written consent.
2. The competition opens on Monday 24 August 2020 and ends at 5pm BST on Friday 30 October 2020. No entries will be accepted after this date.
3. Only one entry can be submitted per child, but there is no limit on the number of individual children per household that may enter.
4. Each entry can include up to five photos and all five activities must have been completed in order to be eligible for the giveaway.
5. By taking part, children will develop their creative writing skills, and are challenged to think imaginatively about their everyday surroundings.
6. All entries must include specified contact details including an adult contact (parent/carer) so that book bundles can be sent to those who enter. Children should **not** appear in the images alongside their work. This information will **not** be shared without receiving consent.
7. Incomplete, illegible or corrupt entries, or those not in accordance with entry instructions, will not be accepted.
8. No responsibility is accepted for entries lost, damaged or delayed as a result of any postal problems or network, computer hardware or software failure of any kind, or where postage is not paid in full. Proof of entry will not be accepted as proof of receipt.
9. All children who complete the challenge will receive a bundle of Roald Dahl books, so long as there is sufficient stock and entries are received prior the closing date. Prize quantity is limited and will be fulfilled on a first come first served basis

10. The judges' decision is final.
11. The prizes are non-transferable and non-exchangeable. However, in the event of unforeseen circumstances, the promoter reserves the right to offer alternative prizes of equal value.
12. Notification of success will be made to the parent/carer of each winner periodically from the opening date of the giveaway.
13. Relevant publicity permissions from parents/carers will also be sought for those who are in receipt of a book bundle. We will send a permission form in advance of sharing personal information with media outlets. Where safeguarding or other concerns apply alternative arrangements may be made. The Promoter will not use such details without seeking prior permission.
14. By taking part in this promotion all entrants will be deemed to have accepted and be bound by these terms and conditions.
15. The promoter accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered as a result of entering this giveaway or accepting the prize. Nothing shall exclude the liability of the promoter for death or personal injury as a result of its negligence.
16. In order to enter the giveaway entrants must provide the name of the entrant, the name and contact details for an adult (parent/carer). This data will be used solely to administer the giveaway and will not be passed to any other parties.
17. Should the arrangement of prizes require any details to be shared, consent will be sought prior to sharing any information. All personal contact details will be destroyed by 30 January 2021, following the winners claiming their prizes.
18. The National Literacy Trust may in their absolute discretion modify, amend, cancel or suspend these terms and conditions at any time if they deem necessary or if circumstances arise beyond their control.
19. The National Literacy Trust reserve the right in their absolute discretion to disqualify from this giveaway any entrant who they believe has not complied with these terms and conditions or acted in good faith.
20. The promoters' decisions are final in all matters relating to this promotion and no correspondence will be entered into.
