Rules for entry

These terms and conditions apply to the Scrapbook of Hopes challenge. The promoters are the National Literacy Trust, the Bupa Foundation and Bloomsbury Publishing.

- 1. The Scrapbook of Hopes challenge is open to schools that have been gifted three copies of *The Book of Hopes* from the National Literacy Trust and the Bupa Foundation.
- 2. The challenge is free of charge to enter.
- 3. Schools may run the challenge without choosing to submit entries.
- 4. The closing date for entries is **31 January 2021** and no entries will be accepted after this date.
- 5. To be entered for the challenge a member of school staff must email <u>bookofhopes@literacytrust.org.uk</u> including a digital file of their Scrapbook of Hopes which must include:
 - a. School contact details including a contact name and email as well as the school name and full address
 - b. Words and pictures that summarise and display the activities run within the school to promote hope and encourage a love of books and reading, inspired by their copies of *The Book of Hopes*
- 6. No responsibility is accepted for entries lost, damaged or delayed as a result of any network, computer hardware or software failure of any kind. Proof of entry will not be accepted as proof of receipt.
- 7. There will not be a notification of receipt for entries.
- 8. Words and photographs provided in your competition entry may be used in the media, on documents, newsletters, websites, and the social media channels of the National Literacy Trust and partners and funders. It is therefore essential that you have obtained parental permission for this in relation to any children included in photographs included in the entry. Any entries without such parental permission will be deemed invalid.
- 9. All eligible entries will be scrutinised by a panel of judges who will be reviewing them to identify ideas and activities that have inspired hope within the school and contributed to strong links with parents/carers and the wider community.
